RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of June 27, 2023, is made by GOLUB CAPITAL MARKETS LLC, as administrative agent for the Lenders and the L/C Issuers (in such capacity, the "Administrative Agent") in favor of BATTERIES PLUS, LLC (the "Grantor"). Capitalized terms used but not defined herein have the meanings given to them in the Trademark Security Agreement (as defined below), whether defined directly therein or by reference to another agreement.

WHEREAS, pursuant to that certain Guaranty and Security Agreement, dated as of July 6, 2016, by and among the Grantor, the Administrative Agent and certain other parties (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), the Grantor executed and delivered in favor of the Administrative Agent that certain Trademark Security Agreement, dated as of July 6, 2016, which was recorded in the United States Patent and Trademark Office ("USPTO") on July 8, 2016 at Reel/Frame 5832/0241 (the "Trademark Security Agreement");

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, the Grantor pledged and granted to the Administrative Agent, for the benefit of the Secured Parties, a Lien on and security interest in (the "Security Interest") all of Grantor's right, title and interest in, to and under (a) all of its trademarks, trade names, corporate names, trade dress, service marks, logos and other source or business identifiers and, in each case, all goodwill associated therewith (other than any "intent-to-use" applications for which a "Statement of Use" or "Amendment to Allege Use" with respect thereto has not been filed with the U.S. Patent and Trademark Office (but only until such statement is filed with the U.S. Patent and Trademark Office, and only to the extent, if any, and only during the period, if any, in which, the grant of a security interest therein would impair the validity or enforceability of any registration issuing from such Trademark application under applicable federal law)), including, without limitation, those referred to on Schedule 1 hereto (the "Trademarks"); (b) all renewals and extensions of the foregoing; (c) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and (d) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under or with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present or future infringement, dilution, violation or other impairment thereof (collectively, the "Trademark Collateral"); and

WHEREAS, the Grantor has requested that the Administrative Agent terminate and release its Security Interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby (i) terminates and cancels the Trademark Security Agreement, (ii) terminates, cancels, discharges and releases its Security Interest in the Trademark Collateral and (iii) re-assigns to the Grantor any right, title or interest it may have in or to the Trademark Collateral, in each case without recourse to the Administrative Agent and without representation or warranty of any kind.

The Grantor (and any successor to the Grantor, including any person or entity hereafter holding any right, title or interest in and to the Trademark Collateral) is hereby authorized to record this Release with the USPTO.





