**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this “Release”), dated as of August 1, 2023, is made by Antares Capital LP, as collateral agent (the “Collateral Agent”) in favor of Xeridem Medical Devices, Inc., an Arizona corporation, PPC Industries Inc., a Delaware corporation, VitalMed, Inc., a Delaware corporation, Spectrum Plastics Holdings, LLC (formerly known as Specialty Processing Intermediate Holding, LLC), a Delaware limited liability company, Apex Resource Technologies, Inc., a Massachusetts corporation, and Fermatex Vascular Technologies, LLC, a Delaware limited liability company (collectively, the “Grantors”), as follows:

WITNESSETH:

WHEREAS, pursuant to that certain First Lien Security Agreement dated as of January 31, 2018 (as amended, supplemented or otherwise modified from time to time, the “Security Agreement”), among the Grantors and the other parties party thereto in favor of the Collateral Agent, and those certain agreements described on Annex I attached hereto (the “IP Security Agreements”), the Grantors granted a security interest in certain collateral in favor of the Collateral Agent, including the IP Collateral (as hereinafter defined); and

WHEREAS, the IP Security Agreements were recorded with the Trademark Division of the United States Patent and Trademark Office and Patent Division of the United States Patent and Trademark Office on the dates and at the reels/frames set forth on Annex I attached hereto; and

WHEREAS, the Agent now desires to terminate and release the IP Security Agreements and the entirety of its security interests granted therein, including in the IP Collateral described on Annex II attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release, the Agent hereby agrees as follows:

1. Definitions. The term “IP Collateral”, as used herein, shall mean, with respect to each Grantor, all of such Grantor’s right, title or interest in, to and under all of its trademarks and patents, including, without limitation, the trademarks and patents listed on Annex II attached hereto, and for clarity, including all Collateral (as defined in each IP Security Agreement) under each IP Security Agreement. Capitalized terms not defined herein have the meanings set forth in the Security Agreement or IP Security Agreements, as applicable.

2. Release of Security Interest. The Collateral Agent, without recourse, representation or warranty and at the Grantors’ sole cost and expense, hereby terminates, cancels, releases, relinquishes and discharges, in its entirety, for the benefit of the Grantors, and their successors and assigns, its security interest in and to the IP Collateral, the IP Security Agreements, and any and all right, title and interest of the Collateral Agent in, to and under the IP Security Agreements, including the IP Collateral, shall hereby be terminated, cancelled, released, relinquished and discharged. The Collateral Agent hereby authorizes the Grantors and their successors, assigns or other legal representatives to file this Release with the United States Patent and Trademark Office, at the sole expense of the Grantors, to evidence and effectuate the release and termination of the Collateral Agent’s security interest in the IP Collateral.


3. Delivery by Facsimile. Delivery of an executed signature page to this Release by facsimile or electronic (including .pdf file) transmission shall be as effective as delivery of a manually signed counterpart of this Release. The parties hereto hereby agree that the electronic signatures of the parties hereto will have the same force and effect as manual signatures.

4. Governing Law. THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HERETO SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.
