**TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Termination"), is dated as of August 1, 2023, and made by PNC BANK, NATIONAL ASSOCIATION, in its capacity as agent for the Lenders ("Agent") to THE HC COMPANIES, INC., a Delaware corporation ("HC Companies"), GROWER EXPRESS TRUCKING, INC., an Ohio corporation ("Grower") and AMERIKAN, LLC, a Florida limited liability company ("Amerikan"), together with HC Companies and Grower, collectively, the "Grantors" and each a "Grantor").

WHEREAS, pursuant to that certain Revolving Credit, Term Loan and Security Agreement dated as of February 17, 2015 (as amended, restated, supplemented or otherwise modified from time to time, include all exhibits and schedules thereto, the "Credit Agreement") among the Grantors, THE HC CANADA OPERATING COMPANY LTD., a corporation incorporated under the laws of the Province of Ontario, (together with each other Person party thereto as a borrower from time to time, collectively, the "Borrowers" and each a "Borrower"), the lenders from time to time party thereto (the "Lenders"), and Agent, the Lenders agreed to make certain financial accommodations available to Borrowers from time to time pursuant to the terms and conditions thereof;

WHEREAS, pursuant to the Credit Agreement, the Grantors entered into that certain Intellectual Property Security Agreement dated as of February 17, 2015 (the "Security Agreement") in favor of the Agent, to secure the payment and performance of the Obligations under the Credit Agreement;

WHEREAS, pursuant to the Security Agreement, a continuing security interest was granted by the Grantors to the Agent in the IP Collateral, including (i) those patents and patent applications (collectively, "Patents") listed on Schedule A attached hereto and all of the goodwill of the business connected with the use of, and symbolized by each such Patent (the "Released Patents"), and (ii) those trademarks, trademark applications, service marks, trade names and mask works (collectively, "Trademarks") listed on Schedule B attached hereto and all of the goodwill of the business connected with the use of, and symbolized by each such Trademark (the "Released Trademarks" and, together with the Released Patents, the "Released Collateral");

WHEREAS, the Security Agreement was recorded at the United States Patent and Trademark Office (the "USPTO"), on February 23, 2015 at Reel/Frame 035004/0320 for Patents and at Reel/Frame 005464/0399 for Trademarks; and

WHEREAS, the Agent now desires to terminate and release the entirety of its security interest solely in the Released Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, the Agent hereby agrees as follows:


1. Definitions. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Credit Agreement or Security Agreement, as applicable.
2. Release of Security Interest. The Agent hereby fully terminates, releases and discharges its security interest in the Released Collateral. If and to the extent that the Agent has acquired any right, title or interest in and to any Released Collateral, the Agent hereby transfers, conveys and assigns such right, title and interest to the applicable Grantor as indicated on Schedule A or Schedule B attached hereto.

3. Authorization. The Agent hereby authorizes the filing and recordation of this Termination with the USPTO or any other governmental office to evidence the termination and release granted by this Termination.
