

On August 1, two thousand and twenty-three, I, notary Maia Bregvadze, was addressed by Akaki Goginashvili and translator Nato Kuzanashvili at my notary office located at Bazaleti St. 1, Tbilisi, Georgia. They said they want to draw up a statement and have their signatures notarized. I checked their identity with the identity documents they presented and made sure that I am addressed by Akaki Goginashvili (born 22.02.1988, citizenship: Georgia, gender: male, personal number: 01002025789 Address: Tbilisi village Digomi, Avtandili St. N 11 apt. 9). I have checked his capacity and I confirm that I had no reason to doubt his capacity.

I established the identity of the translator Nato Kuzanashvili (born on 14.07.1972, resident of Georgia, city of Tbilisi, Ortachala II lane, N 12, apartment 2, personal # 01015001629), with the identity certificate presented by she. I checked the authority of the translator (diploma certifying English and German languages au 025019 issued on 22.06.1995 by I.Chavchavadze Institute of Foreign Languages in Tbilisi, specializing in English and German languages) and warned about the translator's responsibility for wrong translation. Nato Kuzanashvili stated that she knows the English language perfectly and is responsible for the correctness of the translation, after which Nato Kuzanashvili translated this power of attorney, the text of which was approved by the attorney and he personally signed it in my presence.
