RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

WHEREAS, Tigercat International Inc. (the “**Debtor**”), a corporation incorporated under the laws of the Province of Ontario with offices at 200 Avenue Rd, Cambridge, ON N1R 8H5, Canada is the owner of the trademarks, including applications therefor, described on Exhibit 1 annexed hereto (collectively, the “**Intellectual Property**”);

WHEREAS, Royal Bank of Canada (the “**Creditor**”), a Canadian chartered bank incorporated under the laws of Canada with offices at 20 King Street West, 4th Floor, Toronto, Ontario entered into an amended and restated general security agreement with the Debtor dated August 22, 2019 (the “**General Security Agreement**”), and Debtor entered into one or more security agreements governed by the laws of the United States in favor of the Creditor (collectively, the “**US Security Agreement**” and, with the General Security Agreement, the “**Agreements**”), by which Debtor granted to Creditor security interests in the Intellectual Property, among other property;

WHEREAS Notice of Security Interests were filed or recorded, as applicable, against (a) the Canadian trademarks included in the Intellectual Property with the Canadian Intellectual Property office on August 27, 2019, and (b) the United States trademarks, including applications therefor, included in the Intellectual Property with the United States Patent and Trademark Office on August 26, 2019, at Reel 6728, Frame 0726;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Creditor hereby releases, terminates and discharges its security interest in the Intellectual Property.


