TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (“Agreement”) is made and entered into as of July 31, 2023, by and among Stanadyne LLC and Pure Power Technologies, Inc. (each an “Assignor” and collectively, “Assignors”), and Stanadyne Operating Company LLC, a Delaware limited liability company (f/k/a S-PPT Acquisition Company LLC) (“Purchaser”), and Pure Power Technologies LLC, a Delaware limited liability company (together with Purchaser, each an “Assignee” and collectively, “Assignees”).

WHEREAS, Assignors are the owners, as applicable, of the entire right, title, interest and goodwill in and to all of their respective trademarks, either registered, pending or at common law, including, without limitation, the trademarks identified on Schedule A attached hereto (collectively, the “Trademarks”);

WHEREAS, this Agreement is made and entered into in connection with the Closing of the transactions contemplated by that certain Asset Purchase Agreement, dated as of May 8, 2023 (as amended, restated, supplemented or otherwise modified from time to time, the “Purchase Agreement”), by and among Purchaser and each other Person that is a signatory thereto, including, without limitation, Assignors;

WHEREAS, capitalized terms used but not defined herein shall have the respective meanings given to such terms in the Purchase Agreement;

WHEREAS, pursuant to the Purchase Agreement, each Assignor has agreed to sell, transfer, assign, convey and deliver to Purchaser, and Purchaser has agreed to purchase, acquire and accept from each Assignor, all of such Assignor’s direct or indirect right, title and interest in, to and under certain assets (including, without limitation, the Trademarks);

WHEREAS, pursuant to Section 11.9 of the Purchase Agreement, Purchaser has designated the Assignees, and assigned to the Assignees certain rights under the Purchase Agreement, to acquire certain of the Purchased Assets (including, without limitation, the Trademarks) of Assignors in accordance with that certain letter agreement, dated as of the date hereof, by and among Purchaser, Assignees and other parties thereto;

WHEREAS, the execution and delivery of this Agreement is required by Sections 3.2(d) and 3.3(c) of the Purchase Agreement; and

WHEREAS, this Agreement, as duly executed by each Assignee and each Assignor, is being delivered as of the date hereof by each party hereto to the other party effective as of the Closing.

NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Assignor hereby irrevocably and for no royalty, sells, transfers, assigns, conveys and delivers to each applicable Assignee, such Assignor’s entire worldwide right, title and interest in and to, including any and all common law rights thereto in respect of all goods or services in which the Trademarks are registered, as well as the goodwill of the business connected with the use of, and symbolized by, the Trademarks, free and clear of all Encumbrances (other than Encumbrances included in the

Assumed Liabilities and Permitted Encumbrances), as well as any related trademark registrations, common law unregistered trademarks, trade names, service marks, and/or trademark applications; together with all renewals thereof; all rights of any kind whatsoever of Assignor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world; all income, royalties, fees, damages, payments and other proceeds now and hereafter due and/or payable with respect to any and all of the foregoing; any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages; and any and all United States and/or foreign trademark (or service mark) registrations which may be issued on same in the future; provided, however, in relation to each of the foregoing, excluding any trademarks or related rights constituting Excluded Assets. The Assignor agrees that to the extent any Trademarks cannot be assigned to the applicable Assignee for any reason, including by operation of law, the Assignor shall be deemed to have granted to the such Assignee, a worldwide, perpetual, exclusive, royalty free, transferrable, and irrevocable license to all Trademarks therein.

Together with each Assignor's worldwide right, title and interest in and to each of the Trademarks, as well as the goodwill of the business associated with said Trademarks being assigned to such Assignee, are the rights to police, monitor and enforce said Trademarks against any and all past, current and future infringements (including, without limitation, the right to sue for and collect damages caused by any such infringement) which may have occurred at any time in the unlimited past, up to the date of this Agreement, together with any and all further privileges in the United States and throughout the world to establish use, ownership, and registration of the Trademarks.

In accordance with Section 8.12 of the Purchase Agreement, Assignors will cooperate with Assignees, as may be reasonably necessary or appropriate to assist and/or to enable Assignees to record or perfect the above-described transfer of Trademark rights, or to secure registration before the United States Patent and Trademark Office or any foreign trademark office, at Assignees' expense.

Each Assignor hereby further authorizes the Commissioner of Patents and Trademarks of the United States, and the appropriate official in any other country, to issue any and all trademark and service mark registrations, amended registrations and renewals that have been or may be granted upon any application or petition for same, to each applicable Assignee, and such Assignee's successors and/or assigns. Each Assignor shall use reasonable efforts to ensure that copies of all correspondence in relation to the Trademarks (including any renewal notice or other notice received from any government agency) are directed to such Assignee. In the interim, each Assignor shall use reasonable efforts to ensure that copies of all such correspondence are delivered as soon as practical to each applicable Assignee, marked for the attention of the attorney or agent designated by such Assignee, or any other person that such Assignee notified to the Assignor.

Each assignor hereby grants to the designated attorneys of Assignees the authority and power to insert on this instrument any further identification which may be necessary or desirable

for purposes of recordation by the United States Patent and Trademark Office or the trademark office of any other country throughout the world.

This Agreement is executed and delivered pursuant to the Purchase Agreement. The parties hereto acknowledge and agree that the representations, warranties, covenants, agreements and indemnities contained in the Purchase Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of a conflict between the terms and conditions of this Agreement and the terms and conditions of the Purchase Agreement, the terms and conditions of the Purchase Agreement shall govern, supersede and prevail. Notwithstanding anything to the contrary in this Agreement, nothing herein is intended to, nor shall it, extend, amplify or otherwise alter any representation, warranty, covenant or obligation contained in the Purchase Agreement. Notwithstanding the above, the Assignor represents that the assignment of Trademarks under this Agreement shall result in the creation of exclusive rights to the use of Trademarks vesting solely with the Assignees. Further, the Assignor and its affiliates expressly waive the right to prevent Assignees or their affiliates to deal with goods or services bearing Trademarks, including without limitation the right to withdraw the assigned Trademark. It is clarified that all rights vested in the Trademarks associated with rights to use, sell, assign, transfer, modify, delete, or stop any kind of product or services bearing Trademarks are completely transferred to the Assignees with no reservation.

THIS AGREEMENT IS TO BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH FEDERAL BANKRUPTCY LAW, TO THE EXTENT APPLICABLE, AND WHERE STATE LAW IS IMPLICATED, THE LAWS OF THE STATE OF NEW YORK SHALL GOVERN, WITHOUT GIVING EFFECT TO THE CHOICE OF LAW PRINCIPLES THEREOF (EXCEPT SECTIONS 5-1401 AND 5-1402 OF THE GENERAL OBLIGATIONS LAW OF THE STATE OF NEW YORK), INCLUDING ALL MATTERS OF CONSTRUCTION, VALIDITY AND PERFORMANCE.

For the convenience of the parties hereto, this Agreement may be executed and delivered (by facsimile or PDF signature) in any number of counterparts, each such counterpart being deemed to be an original instrument, and all such counterparts shall together constitute the same agreement.
