**TRADEMARK ASSIGNMENT**

WHEREAS, the Parties and the principals of Assignor entered into that certain *Asset Purchase Agreement* dated June 23, 2023 (the “APA”) pursuant to which Assignee purchased and acquired all rights, title, and interest in and to all of the assets of Assignor, including but not limited to, all trademarks and service marks of Assignor including the Assigned Trademarks and all goodwill and common law rights therein; and

WHEREAS, the Parties now wish to memorialize in writing for recordation purposes the assignment of the Assigned Trademarks effected by the APA as of the date of the APA.

THEREFORE, BE IT KNOWN that for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns, transfers, and conveys to Assignee, its successors and/or assigns, effective *nunc pro tunc* as of the date of the APA, free and clear of all liens and encumbrances, all of Assignor’s entire right, title and interest, including all common law rights and rights of priority that may exist therein, in and to the Assigned Trademarks and in and to any registrations, renewals and extensions that may be granted thereon, together with the goodwill of the business connected therewith and/or symbolized thereby and any right to recover for past or future infringement(s) thereof. For the avoidance of doubt, the Parties expressly agree that the assignment herein is effective as of the same date as the APA, namely, June 23, 2023 as if the Parties had executed this Assignment concurrently with the APA.
