Recital





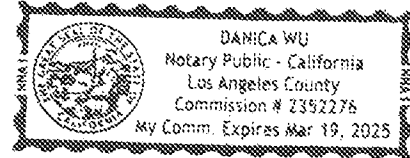
