TRADEMARK ASSIGNMENT AGREEMENT

This agreement (“Agreement”), having an effective date of the last signature date below, is entered by and between: Boardvantage, Inc. NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

- 1. The “Boardvantage Trademark” is the trademark for BOARDVANTAGE, including all rights associated therewith, across the world, including U.S. Trademark Registration No. 2,748,647 (including all renewals or extensions thereof), all common law rights therein, all goodwill associated therewith, and all claims and causes of action, past and future, relating to infringement, dilutions, or other violations thereof.
- 2. Assignment. Assignor hereby assigns and transfers to Assignee, and Assignee hereby accepts, the entirety of Assignor’s entire right, title, and interest in the Boardvantage Trademark.
