Trade Mark Assignment Agreement

This TRADE MARK ASSIGNMENT AGREEMENT (this "Trade Mark Assignment"), is made as of the 8th day of June, 2023 (the "Effective Date"), by and between ABG-TB IPCO (UK) Limited, a private limited company (registered in England with registration number 13767476) ("Assignee") and No Ordinary Design Label Limited, a private limited company (registered in England with registration number 02509755) ("Assignor").

WHEREAS, Assignor desires to assign and Assignee desires to acquire the registered trademarks and trademark applications identified on Schedule A attached hereto and made a part hereof, including all goodwill associated therewith and symbolized thereby (collectively, the "Trade Marks").

NOW THEREFORE, the parties hereto, intending to be legally bound, agree as follows:

1. Assignment. Assignor does hereby irrevocably sell, assign, convey, transfer and deliver to Assignee, its successors and assigns: (a) all of Assignor's worldwide right, title and interest in, to and under, including any and all common law rights thereto, the Trade Marks, including, without limitation, any registrations, applications, renewals and extensions therefor, together with the goodwill associated and symbolized thereby, effective as of the date hereof; and (b) all other rights accruing thereunder or pertaining thereto in any jurisdiction throughout the world for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors and assigns, as full and entirely as the same would have been held and enjoyed by Assignor if this Trade Mark Assignment had not been made, including: (i) claims, causes of actions and rights to pursue and collect damages, costs, injunctive relief and other remedies for past, current or future infringement, misappropriation, dilution, conflict with or other violation of any of the foregoing, and all income, royalties or payments due or payable as of the date hereof or hereafter in respect of any of the foregoing; and (ii) rights to apply in any or all countries of the world for protection for the Trade Marks, in each case, effective as of the date hereof. Together with Assignor's worldwide right, title and interest in and to each of the Trade Marks, as well as the goodwill associated therewith being assigned to Assignee, are the rights to police, monitor and enforce said Trade Marks against any and all past, current and future infringements (including, without limitation, the right to sue for and collect damages caused by any such infringement) which may have occurred at any time in the unlimited past, up to the date of this Trade Mark Assignment, together with any and all further privileges in the United Kingdom, United States, European Union and throughout the world to establish use, ownership, and registration of the Trade Marks.

2. Authorization and Recordation. Assignor hereby authorizes and requests any Intellectual Property Offices or any other applicable governmental authority or registrar to record and register Assignee as the owner of the Trade Marks, and to issue any and all Trade Marks to Assignee, as assignee of all of Assignor's right, title and interest in and to the Trade Marks. Assignee shall have the right to record this Trade Mark Assignment with all applicable governmental authorities and registrars so as to perfect ownership of the Trade Marks.

3. Further Assurances. Within a reasonable time of being requested to do so in writing, without further consideration, Assignor hereby agrees, for itself and its successors and

assigns, to promptly execute and deliver, or promptly cause to be executed and delivered, all such further documents or perform all affirmative acts which may be necessary or desirable to record or perfect the above-described transfer of the Trade Marks, or to secure registration before any registrar office of any country throughout the world (including executing, acknowledging and delivering to Assignee such further assurances, deeds, assignments, powers of attorney, bills of sale, consents and other instruments and documents as Assignee may reasonably request) in order to more fully consummate the transactions contemplated herein and in order to more effectively vest, transfer, and confirm the right, title and interest of Assignee in the Trade Marks. Assignor hereby grants to the designated attorneys of Assignee the authority and power to insert on this instrument any further identification which may be necessary or desirable for purposes of recordation by any registrar office of any country throughout the world, provided that Assignee has given Assignor prior notice of the insertion of such further identification. Until such time as all of the assignments of the Trade Marks in all jurisdictions set forth in the annexed Schedule are duly recorded by Assignee with the responsible government offices (the "Interim Period"), Assignor acknowledges and confirm that Assignee shall, in any event, be deemed to be the owner of the Trade Marks. If it shall be necessary to record this Trade Mark Assignment or other confirmatory documentation during the Interim Period, or in the event that any of Assignor's Trade Marks shall become due for any maintenance filings, renewals or other recordations during the Interim Period, Assignor shall likewise reasonably cooperate with Assignee's requests and hereby consent and grant to Assignee the right to take all required actions, at Assignee's expense, to maintain and enforce all registrations and other filings worldwide. All recordations and filings of any assignments hereunder shall be made by Assignee at Assignee's expense. The Assignor shall use all reasonable endeavours to procure that any third party shall promptly execute such documents and perform such acts as the Assignee may request to give full effect to this Trade Mark Assignment and secure to the Assignee or any successor in title the full benefit of the rights assigned to the Assignee under this Trade Mark Assignment.

4. Counterparts. This Trade Mark Assignment may be executed in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same agreement. Such counterparts may be delivered in electronic format (including by electronic mail).


5. Governing Law. This Trade Mark Assignment and any non-contractual obligations arising out of or in connection with it shall be governed and construed in accordance with English law. The courts of England and Wales shall have exclusive jurisdiction to settle any dispute arising out of or in connection with this Trade Mark Assignment (including a dispute relating to the existence, validity or termination of this Trade Mark Assignment or any non-contractual obligation arising out of or in connection with this Trade Mark Assignment) (a "Dispute"). The Parties agree that the courts of England and Wales are the most appropriate and convenient courts to settle Disputes and accordingly no Party will argue to the contrary.
