

GRANT OF SECURITY INTEREST (TRADEMARKS)
(LINE)

July 5, 2023

The undersigned, **S. ROTHSCHILD & CO., INC.**, a New York corporation (the "Grantor"), together with **FIELDSTON CLOTHES, INC.**, a New Jersey corporation, **RIVER FALLS MANUFACTURING CORP.**, a New York corporation, **MAJOR MAJOR, LLC**, a New York limited liability company, and **MMJ APPAREL LLC**, a New York limited liability company (collectively with the Grantor, the "Borrowers"), and **ISRAEL DISCOUNT BANK OF NEW YORK** (the "Secured Party"), are parties to a certain Amended and Restated of Credit Agreement, dated as of the date hereof (as amended, restated, supplemented or otherwise modified from time to time, the "Line of Credit Agreement") pursuant to which the Secured Party has established for the Borrowers an uncommitted discretionary demand line of credit. In connection therewith, the Borrowers have entered into a certain Amended and Restated Pledge and Security Agreement, dated as of the date hereof (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") with the Secured Party.

Pursuant to the Security Agreement, the Grantor has granted to the Secured Party a security interest in and to all of the right, title and interest of the Grantor in and to the trademarks listed on Schedule 1, which trademarks are registered in the United States Patent and Trademark Office (the "Trademarks"), together with the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof (the "Collateral"), to secure the prompt payment, performance and observance of the Obligations (as defined in the Security Agreement).

For good and valuable consideration, the receipt of which is hereby acknowledged, and for the purpose of recording the grant of the security interest as aforesaid, the Grantor does hereby further grant to the Secured Party a security interest in, the Collateral to secure the prompt payment, performance and observance of the Obligations (as defined in the Security Agreement).

The Grantor does hereby further acknowledge and affirm that the rights and remedies of the Secured Party with respect to the security interest in the Collateral granted hereby are set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.


The Grantor does hereby further acknowledge and agree that this Grant of Security Interest (a) amends and restates the Grant of Security Interest (Trademarks), dated March 24, 2010, made by the Grantor in favor of the Secured Party (the "Existing Grant of Security Interest"), (b) does not constitute a novation or termination of Grantor's obligations under the Existing Grant of Security Interest, and (c) does not constitute a termination of the security interest granted under the Existing Grant of Security Interest and such security interest is in all respects continuing.
