TRADEMARK ASSIGNMENT

B. Pursuant to the terms of to the ASSET PURCHASE AGREEMENT, dated November 18, 2022 between Assignor and Assignee (the "Purchase Agreement"), Assignee hereby provides Assignor with notice of Assignee's exercise of the option to acquire from Assignor, all worldwide right, title and interest in and to the Trademarks.

C. Capitalized terms used herein and not otherwise defined shall have the meaning assigned to them by the Purchase Agreement.

AGREEMENT:

NOW, THEREFORE, in consideration of such payment as set forth in the Purchase Agreement and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound hereby, Assignor hereby sells, assigns, and transfers unto Assignee the entire right, title, and interest in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks, and all claims for damages by reason of past infringement of the Trademarks, with the right to sue for and collect the same for its own use and enjoyment, and for the use and enjoyment of its successors, assigns, and other legal representatives.

Assignor agrees that it shall execute and/or deliver any additional instrument, and shall take any additional step, reasonably requested by Assignee in order to effect, evidence, or perfect Assignee's rights in and to the Trademarks.




