Seller, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, does hereby sell, convey, transfer and assign to Buyer, and Buyer hereby accepts the sale, conveyance, transfer and assignment of all right, title and interest of Seller in, to and under the Trademarks, including all worldwide right, title and interest of Seller in, to and under the Trademarks, together with the right of Seller to claim priority in all countries in accordance with international law, any and all rights of Seller corresponding to said Trademarks in countries throughout the world, and all of Seller's rights to sue for past, present or future infringement of said Trademarks worldwide together with all claims for damages by reason of past, present or future infringement of said Trademarks, and the right to sue for and collect the same for Buyer's own use and enjoyment, all to be held and enjoyed by said Buyer, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Seller had this Assignment not been made. Seller hereby authorizes and requests the United States Patent and Trademarks Office to issue said Trademarks in accordance with this Assignment.

3. Upon the consummation of this Assignment, the Seller's conveyance, transfer and assignment of the Trademarks shall be rendered on an "AS IS" and "WHERE IS" basis. Seller represents and warrants that upon information and belief, Seller has full and complete authority to make this Assignment.

4. This Assignment may be executed in multiple counterparts, each of which shall be deemed an original hereof, and all of which shall constitute a single agreement effective as of the date hereof. Any delivery of an executed counterpart of this Assignment by facsimile or electronic mail shall be as effective as delivery of a manually executed counterpart of this Assignment.

5. This Assignment shall be binding upon and shall inure to the benefit of the parties and their respective successors and assigns.


