**RELEASE AND REASSIGNMENT OF  
GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS**

THIS RELEASE AND REASSIGNMENT OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS is made as of August 4, 2023, by GRAYCLIFF MEZZANINE III LP, as collateral agent acting for the benefit of the Secured Parties (in such capacity, the “Collateral Agent”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Trademark Security Agreement (as defined below).

WITNESSETH:

WHEREAS, BAYFIRST SOLUTIONS LLC, a Delaware limited liability company (“Grantor”), and the Collateral Agent are parties to that certain Grant of Security Interest in Trademark Rights, dated as of June 1, 2021 (the “Trademark Security Agreement”) pursuant to which the Grantor granted a security interest to the Collateral Agent for the benefit of the Secured Parties in certain Trademarks and Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to the Collateral Agent for the benefit of the Secured Parties, including the trademarks set forth on Schedule A hereto;

WHEREAS, the Trademark Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on June 1, 2021, at Reel 7312, Frame 0375;

WHEREAS, Grantor has requested that the Collateral Agent release its security interest in the Trademarks and Trademark Collateral and reassign any and all rights in the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. The Collateral Agent hereby releases its security interest in all of Grantor’s right, title and interest in, to and under all of the Grantor’s Trademarks including, without limitation, those trademarks listed on Schedule A hereto (collectively the “Trademark Collateral”).
2. The Collateral Agent hereby reassigns, grants and conveys to the Grantor, without any representation, recourse or undertaking by the Collateral Agent, any and all of the Collateral Agent’s right, title and interest in and to the Trademarks and Trademark Collateral.
3. The Collateral Agent hereby terminates and cancels the Trademark Security Agreement.
