STATEMENT OF MERGER

Pursuant to the applicable provisions of the Pennsylvania Entity Transactions Law (15 Pa. C.S.A. § 311 et seq.), Chapter 3 of the Pennsylvania Associations Code (15 Pa. C.S.A. § 101 et seq.), the undersigned, desiring to effect a merger (the "Merger"), hereby state that:

1. **Surviving Corporation.** The name of the corporation surviving the Merger is Andritz Metals Inc. (the "Surviving Corporation").

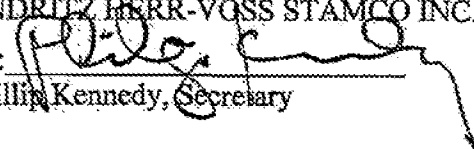
