### RELEASE OF SECURITY INTEREST IN TRADEMARKS

("Holdings"), the lenders party thereto from time to time and KEYBANK NATIONAL ASSOCIATION, as administrative agent (the "Administrative Agent"), (ii) certain Pledge and Security Agreement, dated as of September 3, 2020 (as amended, restated, amended and restated, supplemented, waived or otherwise modified from time to time on or before the date hereof, the "Security Agreement"), between the Pledgors, Holdings and the Administrative Agent, and (iii) certain Collateral Assignment of Trademarks, dated as of October 7, 2022 (the "Trademark Security Agreement"), executed by the Pledgors in favor of the Administrative Agent, the Pledgors pledged and granted to the Administrative Agent a security interest in and continuing lien on all of the Pledgors' right, title and interest in, to and under Trademarks, including but not limited to the Trademarks listed on Schedule 1 attached hereto (collectively, the "Trademark Collateral"); and

**WHEREAS,** the security interest in the Trademark Collateral pledged and granted by the Pledgors to the Administrative Agent under the Trademark Security Agreement was recorded at the United States Patent and Trademark Office on October 10, 2022, at Reel 007873, and Frame 0118; and
