TRADEMARK ASSIGNMENT

This Trademark Assignment is made effective as of July 10, 2023 by and between Girls' Life Acquisition Corp., a Delaware Corporation having a principal place of business at: 616 Water Street, Baltimore, Maryland 21202 (hereinafter "Assignor") and the sole Trustee of the Robert H. Bokram Trust, a Maryland trust, the sole trustee comprising Karen Bokram ("Trustee"), a U.S. citizen, having an address located at: 326 Saint Dunstons Road, Baltimore MD, 21212 (hereinafter "Assignee") (each a "Party" or collectively "Parties").

WHEREAS, pursuant to an Assignment dated August 18, 2006 between Girls' Life, Inc. and Assignor, Assignor became the owner of and remains the current owner of the following United States trademark and trademark registration (hereinafter referred to as the "Mark"):

GIRLSLIFE.COM: U.S. Trademark Registration No. 2,713,045, filed on February 12, 2002, and claiming a date of first use and first use in commerce in September 1996 for:

- Providing and *[sic]* online magazine featuring articles and advice concerning friends, family, school, careers, fashion, music, news and shopping tips of interest for girls from the ages of 10 to 15 in International Class 41;

WHEREAS, Assignor wishes to transfer all of its rights, title, and interest in the Mark to Assignee; and

WHEREAS, Assignee is desirous of obtaining any and all rights, title, and interest that Assignor may have in and to the Mark since its first use, together with the goodwill of the business in connection with which the Mark is used and which is symbolized by the Mark; along with the right to recover damages and profits for past, present, and future infringement thereof, as fully as if Assignor had used and filed such trademark in its own name.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

Assignor does hereby assign unto Assignee all Assignor's right, title and interest in and to the Mark in the United States and throughout the world, together with the goodwill of the business in connection with which the Mark is used and which is symbolized by the Mark, along with the right to recover for damages and profits for past, present, and future infringement thereof.

Assignor does further agree to execute and deliver without further consideration all further applications, assignments and documents, and to perform such other acts as Assignee may reasonably request or that are deemed necessary by Assignee, its successors, assigns and nominees, and to fully secure Assignee's ownership interest in the Mark as aforesaid. The Assignor hereby appoints the Trustee of the Assignee as its due and lawful attorney-in-fact with the power of attorney to execute such documents and take such acts under this paragraph as Assignor was required to execute or take, such power being coupled with an interest herein and irrevocable.

This Trademark Assignment may be executed in multiple counterparts, each of which shall be deemed an original but all of which together shall constitute one and the same instrument. Electronic, scanned or other electronically signed versions shall be deemed originals for all purposes herein.
