

Correction to Assignment

U.S. Trademark Registration No. 4149734 for ACORN TV was assigned from Acorn TV, LLC, a Delaware limited liability company, to ACORN MEDIA GROUP, INC., assignment effective December 18, 2012. This assignment was recorded with the USPTO at Reel/Frame 4921/0821. In the assignment document, ACORN MEDIA GROUP, INC. was described as a Maryland corporation. However, ACORN MEDIA GROUP, INC. was always a District of Columbia corporation; the Maryland corporation did not exist and referring to ACORN MEDIA GROUP, INC. as a Maryland corporation was simply a clerical error in identifying the assignee.



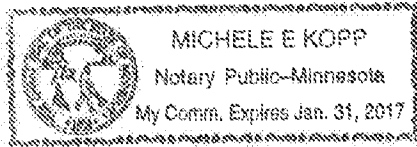
