**TERMINATION AND RELEASE  
OF SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “**Release**”) is executed as of August 8, 2023 by Computershare Trust Company, N.A., as successor to Wells Fargo Bank, National Association, as the trustee and collateral agent (the “**Secured Party**”) under the Indenture dated as of June 5, 2019, as amended (the “**Indenture**”), relating to CNG Holdings, Inc.’s 12.500% Senior Secured Notes due 2024. Capitalized terms used but not defined herein shall have the meanings assigned to them in the Indenture.

**WHEREAS**, pursuant to the terms of that certain Second Supplemental Indenture dated as of August 3, 2023 (the “**Second Supplemental Indenture**”) by and among Allied Cash Holdings LLC, a Delaware limited liability company (the “**Company**”), certain affiliates of the Company and the Secured Party, the security interest of the Secured Party in the Collateral, including, without limitation, in the Trademark Collateral, as such term is defined in the Grant of Trademark Security Interest dated as of June 5, 2019, recorded with the United States Patent and Trademark Office on June 5, 2019 at Reel 6663 / Frame 0367 (the “**Grant**”), and the Liens granted pursuant to the Collateral Documents (including the Grant) to secure the Indenture Obligations were discharged and released and the Collateral Documents (including the Grant) were terminated.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party states as follows:

The Secured Party hereby acknowledges the termination, release, and discharge of the Secured Party’s security interest in and continuing Lien on all of the Company’s right, title and interest in and to the Trademark Collateral, including, without limitation, the trademarks scheduled on Schedule A attached hereto and the termination of the Grant.

The Secured Party understands and agrees that this Release may be recorded by or for Company with the United States Patent or Trademark Office or any similar office or agency within the United States.
