LabOne, Inc., a for profit corporation of the State of Missouri duly organized and existing under the laws of the State of Missouri (the "Corporation"), in order to convert itself into a limited liability company of the State of Missouri, does hereby certify as follows:

FIRST: The name of the Corporation is LabOne, Inc. The name under which the Corporation was originally incorporated was BMA Properties, Inc.

SECOND: The Corporation was formed as a corporation of the State of Missouri pursuant to Articles of Incorporation filed on December 23, 1974, with the Missouri Secretary of State.

THIRD: The Corporation shall be converted to a limited liability company of the State of Missouri. The name of the limited liability company immediately after the filing of this Certificate of Conversion shall be LabOne, LLC.

FOURTH: The conversion of the Corporation into LabOne, LLC has been approved, in accordance with Section 351.409 of the General and Business Corporation Law of Missouri, by resolution adopted by the Board of Directors of the Corporation on December 22, 2014, and by resolutions adopted by the sole stockholder of the Corporation on December 22, 2014.

FIFTH: The Corporation agrees that it may be served with process in the State of Missouri in any action, suit or proceeding for enforcement of any obligation of the Corporation arising while it was a corporation of the State of Missouri. The Corporation irrevocably appoints the Missouri Secretary of State as its agent to accept service of process in any such action, suit or proceeding.



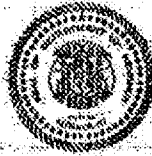


