**RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST**

This Release of Intellectual Property Security Interest (this "Release") is given effective as of August 9, 2023 by Espresso Capital Ltd. ("Espresso").

WHEREAS, pursuant to that certain Intellectual Property Security Agreement, dated as of March 22, 2021, executed by AuthenticID Inc. (the "**Borrower**") in favor of Espresso (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "**IP Security Agreement**"), Borrower granted Espresso a Lien (as defined in the IP Security Agreement) on and security interest in, all of its right, title and interest in, to and under the following (the "Collateral"): (i) all its patents, trademarks and all intellectual property licenses providing for the grant by or to such Borrower of any right under any patent or trademark, including, without limitation, those referred to in Schedule A attached hereto, (ii) all renewals and extensions of the foregoing, (iii) all goodwill of the business connected with the use of, and symbolized by, each such patent or trademark, and (iv) all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof;

WHEREAS, the IP Security Agreement was recorded with the patent or trademark, as applicable, division of the United States Patent and Trademark Office on March 22, 2023, at Reel/Frame: 7238/0507.

WHEREAS, Espresso now desires to release the entirety of its security interest in the Collateral.

NOW, THEREFORE, intending to be legally bound hereby and in connection with the IP Security Agreement, Espresso hereby (i) releases the continuing security interest and continuing lien upon, and terminates its security interest in, to, and under, and all other rights, title and interest in, to, and under the Collateral, without any recourse, representation or warranty, (ii) terminates the IP Security Agreement, and (iii) re-assigns to Borrower, any right, title or interest Espresso may have in, to or under the Collateral, together with the goodwill of the business symbolized thereby, and hereby authorizes **Borrower or Borrower's** authorized representative or designee to record this Release with the United States Patent and Trademark Office as evidence of such release and termination.
