RELEASE OF SECURITY INTERESTS IN TRADEMARKS

11 August, 2023

The undersigned, on behalf of itself and the Senior Secured Parties and the Junior Secured Parties, hereby fully and completely releases and discharges the liens and security interests in all trademarks and trademark applications granted by Hunter Boot Limited, a company organized under the laws of Scotland, on behalf of itself and its affiliates Hunter Boot USA LLC, a limited liability company organized under the laws of Delaware, and Hunter of Scotland Limited, a corporation organized under the laws of Delaware (each a “*Grantor*”, and, collectively, the “*Grantors*”), to Pall Mall Secondary AM S.Á R.L., a company organized under the laws of Luxembourg (the “*Agent*”), in its capacity as security agent for the Senior Secured Parties under the Notes Issuance Facility Agreement and the Junior Secured Parties under the Note Issuance Facility Agreement, which security interests were granted pursuant to the US Senior Notes Security Agreement, dated as of June 8, 2020, the Trademark Security Agreement, dated as of June 8, 2020, the US Junior Notes Security Agreement, dated as of June 8, 2020, and the Trademark Security Agreement, dated as of June 8, 2020, respectively (together, the “*US Security Agreements*”), and includes the trademark registrations set forth on Schedule A attached hereto. All capitalized terms used but not otherwise defined herein shall have the meaning given to them in the US Security Agreements.

Such security interests were recorded with the United States Patent and Trademark Office on June 8, 2020, on Reel/Frame: 006955/0762, and on June 9, 2020, on Reel/Frame 006956/0392, and this release shall include (i) all of the trademarks and trademark applications subject to the grant by the Grantors to the Senior Secured Parties and the Junior Secured Parties, including those trademark registrations identified and set forth on Schedule A hereto; (ii) any right under the trademarks or trademark applications; (iii) any goodwill connected with and symbolized thereby, and all goodwill of the business connected with the use of, and symbolized by, each such trademark; (iv) all renewals and extensions of the foregoing; and (v) all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

This release shall be governed by, and construed in accordance with, the laws of the State of New York.


