The assignment includes any causes of action relating to the Trademark and Application, as well as the right to recover for past infringement. ASSIGNOR makes no representations or warranties or promises, express or implied, regarding ASSIGNOR’S rights in or ownership of the Trademark and Application, or the validity of the Trademark and Application.
