**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of August 14, 2023, is made by WILMINGTON TRUST, NATIONAL ASSOCIATION, in its capacity as Notes Collateral Agent (referred to herein as the “Notes Collateral Agent”) CAPELLA HEALTHCARE, LLC, a Delaware limited liability company, ESSENT HEALTHCARE, INC., a Delaware corporation, KERSHAW HOSPITAL, LLC, a South Carolina limited liability company, RCHP-FLORENCE, LLC, a Delaware limited liability company, RCHP-OTTUMWA, LLC, a Delaware limited liability company, RCHP-WILMINGTON, LLC, a Delaware limited liability company, LIFEPOINT HEALTH, INC., a Delaware corporation, WILLAMETTE VALLEY MEDICAL CENTER, LLC, a Delaware limited liability company, COMMUNITY HOSPITAL OF ANDALUSIA, LLC, a Delaware limited liability company, DANVILLE REGIONAL MEDICAL CENTER, LLC, a Delaware limited liability company, PHC-LAS CRUCES, INC., a New Mexico corporation, PROVIDENCE HOSPITAL, LLC, a Delaware limited liability company, SUMNER REGIONAL MEDICAL CENTER, LLC, a Delaware limited liability company, ADVANTAGEPOINT HEATH ALLIANCE, LLC, a Delaware limited liability company (each a “Pledgor”, and together the “Pledgors”). Capitalized terms not defined herein shall have the meaning ascribed to them, directly or by reference, in the Trademark Security Agreement (as defined below).

WHEREAS, the Pledgors, together with the other pledgors party thereto, executed and delivered that Collateral Agreement (Senior Secured Notes), dated as of April 13, 2020, in favor of the Notes Collateral Agent (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”);

WHEREAS, pursuant to the Collateral Agreement and the Trademark Security Agreement, the Pledgors, and the other pledgors party thereto, granted and pledged to the Notes Collateral Agent, for the benefit of the Secured Parties, a security interest (the "Security Interest") in the IP Collateral as security for the payment and performance, as applicable, in full of the Secured Obligations; and

WHEREAS, the IP Collateral included the Trademarks listed on Schedule A hereto (the "Released Trademark Collateral"), and Pledgors have requested that the Notes Collateral Agent now terminate and release its Security Interest in the Released Trademark Collateral.


NOW THEREFORE, in consideration of the foregoing and for other good and valuable consideration the receipt and adequacy of which are hereby acknowledged, the Notes Collateral Agent hereby terminates and releases the Security Interest in the Released Trademark Collateral which had been granted to it by Pledgors pursuant to the Collateral Agreement and the Trademark Security Agreement, without recourse to, or representation or warranty by, the Notes Collateral Agent. For the avoidance of doubt, except as expressly set forth above, nothing herein shall affect the Security Interest held by the Notes Collateral Agent in the IP Collateral, or any other security interest granted by Pledgors or any other pledgors to the Notes Collateral Agent.

Each Pledgor (and any successor to such Pledgor, including any person or entity hereafter holding any right, title or interest in and to the Released Trademark Collateral of such Pledgor) is hereby authorized to record this Release with the United States Patent and Trademark Office, at the applicable Pledgor's sole cost and expense.






