RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS** is dated as of August 11, 2023 (this “**Release**”), and executed and delivered by BANK OF AMERICA, N.A., as Collateral Agent (the “**Collateral Agent**”), in favor of NEW ERA CAP GLOBAL, LLC, a Delaware limited liability company, NEW ERA CAP, LLC, a Delaware limited liability company, and 5TH & OCEAN CLOTHING, LLC, a New York limited liability company (collectively, the “**Grantors**”).

WHEREAS, reference is made to (a) the Asset Based Loan and Guaranty Agreement dated as of January 13, 2022 (as amended, restated, supplemented or otherwise modified from time to time, the “**Credit Agreement**”), among New Era Cap Global, LLC, a Delaware limited liability company (“**Holdings**”), New Era Cap, LLC, a Delaware limited liability company (the “**Initial US Borrower**”), New Era Cap Company, an unlimited company organized under the laws of Nova Scotia, Canada (the “**Initial Canadian Borrower**”), New Era Cap Company Limited, a company incorporated under the laws of England and Wales with company number 04599312 (the “**Initial UK Borrower**”; the Initial US Borrower, the Initial Canadian Borrower and the Initial UK Borrower, collectively, the “**Borrowers**”), certain Subsidiaries of Holdings party thereto, the Lenders and Issuing Banks party thereto and Bank of America, N.A., as Administrative Agent and Collateral Agent, and (b) the US Pledge and Security Agreement referred to therein (as amended, restated, supplemented or otherwise modified from time to time, the “**Collateral Agreement**”);

WHEREAS, pursuant to the Collateral Agreement, the Grantors, respectively, executed and delivered that certain ABL Patent and Trademark Security Agreement, dated as of February 1, 2022 (the “**First ABL Patent and Trademark Security Agreement**”), whereby each Grantor granted to the Collateral Agent, its successors and assigns, for the benefit of the Secured Parties (as defined in the Credit Agreement), a security interest in all of such Grantor’s right, title and interest in, to and under any and all of the following assets then owned or at any time thereafter acquired by such Grantor or in, to or under which such Grantor then had or at any time thereafter may have acquired any right title or interest (the “**Patent and Trademark Collateral**”):

(a) (i) all letters patent of the United States of America and Canada or the equivalent thereof in any other country, all registrations and recordings thereof and all applications for letters patent of the United States of America and Canada or the equivalent thereof in any other country or any political subdivision thereof, including registrations, recordings and pending applications in the United States Patent and Trademark Office, the Canadian Intellectual Property Office or any similar offices in any other country or any political subdivision thereof, including, in the case of any Grantor, any of the foregoing set forth under its name on Schedule I hereto, and (ii) all reissues, continuations, divisionals, continuations-in-part, reexaminations, supplemental examinations, *inter partes* reviews, renewals, adjustments or extensions thereof, and the inventions disclosed or claimed therein, including the right to make, have made, use, sell, offer to sell, import or export the inventions disclosed or claimed therein; and

(b) (i) all trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, domain names, global top level domain names, other source or business identifiers, designs and general intangibles of like nature, all registrations and recordings thereof, and all registration and recording applications filed in connection therewith, including registrations and registration applications in the United States Patent and Trademark Office, the Canadian Intellectual Property Office or any similar office in any State of the United States of America or any other country or any political subdivision thereof, all extensions or renewals thereof, and all common law rights related thereto, including, in the case of

any Grantor, any of the foregoing set forth under its name on Schedule II hereto, (ii) all goodwill associated therewith or symbolized thereby and (iii) all other assets, rights and interests that uniquely reflect or embody such goodwill.

WHEREAS, the First ABL Patent and Trademark Security Agreement was recorded with the United States Patent and Trademark Office on February 2, 2022, at (x) Reel 058863 and Frame 0560 and (y) Reel 007607 and Frame 0101 and with the Canadian Intellectual Property Office on March 8, 2022 at file number 1048941; and

WHEREAS, the Collateral Agent desires to release any security interest it has in or to the Patent and Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

SECTION 1. Terms. Each capitalized term used but not otherwise defined herein shall have the meaning specified in the Credit Agreement or the Collateral Agreement, as applicable. The rules of construction specified in Section 1.3 of the Credit Agreement also apply to this Release, mutatis mutandis.

SECTION 2. Release of Security Interest. The Collateral Agent does hereby release and convey to the Grantors all of the Collateral Agent's right, title and interest in or to the Patent and Trademark Collateral. The Collateral Agent authorizes and requests that the United States Commissioner for Patents and Trademarks, the Canadian Intellectual Property Office and any other applicable officer in any successor office or any similar office in any other country record this Release.


