Pursuant to the provisions of Section 264 of the Delaware General Corporation Law (the "DGCL") and Section 18-209 of the Delaware Limited Liability Company Act (the "DLLCA"), TW Web, LLC, a Delaware limited liability company ("TW Web LLC"), hereby certifies the following information relating to the merger (the "Merger") of TicketWeb Inc., a Delaware corporation ("TW Inc"), with and into TW Web LLC:

1. The constituent entities which are to merge are:

- (i) TW Web, LLC, a Delaware limited liability company; and
- (ii) TicketWeb Inc., a Delaware corporation.

2. An agreement and plan of merger (the "Merger Agreement") has been approved and executed by each of TW Web LLC in accordance with its limited liability company agreement and Section 18-209 of the DLLCA and TW Inc in accordance with the provisions of subsection (c) of Section 264 of the DGCL.

3. The business entity surviving the Merger is TW Web, LLC, which will be re-named "TicketWeb, LLC" in the Merger.

4. The executed Merger Agreement is on file at the principal place of business of the surviving domestic limited liability company, the address of which is as follows:

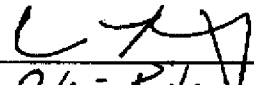
