RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST (“**Release**”) is made and effective as of the date executed below, and is granted by TRIPLEPOINT VENTURE GROWTH BDC CORP., a Maryland corporation having an address of 2755 Sand Hill Road, Suite 150 Menlo Park, California 94025 (“**TriplePoint**”) under the Security Agreement referred to below, in favor of MIND CANDY LIMITED, a company organized under the laws of the United Kingdom with an address of 4th Floor, Bonhill Building 15 Bonhill Street London, United Kingdom EC2A4DN (“**Mind Candy**”).

WHEREAS, all the right, title and interest of U.S. Trademark Registration No. 4,832,026 for the “POPPET” standard character mark, and U.S. Trademark Registration No. 4,603,967 for the “POPPET” stylized design trademark, as set forth and described in Exhibit A attached hereto, are owned by Mindy Candy, which are collectively referred to herein as the “**Trademark Collateral**”;

WHEREAS, pursuant to that certain Plain English Intellectual Property Security Agreement dated as of January 26, 2016 (the “**Security Agreement**”) between Mindy Candy and TriplePoint, Mindy Candy pledged and granted to TriplePoint a security interest in and to all of the right, title and interest of Mindy Candy to those certain items of intellectual property identified in the Security Agreement, including the Trademark Collateral;

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office at reel/frame 005717/0738 on January 27, 2016; and

WHEREAS, Mindy Candy has requested that TriplePoint enter into this Release in order to effectuate, evidence and record the termination, release, discharge, and reassignment to Mind Candy of any and all right, title and interest that TriplePoint may have in and to the Trademark Collateral pursuant to the Security Agreement, and further with the understanding that Mindy Candy will record this Release with the United States Patent and Trademark Office as proof of the termination, release and discharge of TriplePoint’s security interest in and to the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, TriplePoint hereby states as follows:

- 1) **Release of Security Interest in Trademark Collateral.** TriplePoint, on behalf of itself and its successors, legal representatives and assigns, hereby terminates, releases and discharges any and all security interests that it has pursuant to the Security Agreement in and to any and all right, title and interest to the Trademark Collateral.
- 2) **Governing Law.** This Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Release and the transactions contemplated hereby shall be governed by, and construed in accordance

with, the laws of the United States and the State of California, without giving effect to any choice or conflict of law provision or rule whether of the State of California or any other jurisdiction.
