## TERMINATION OF TRADEMARK SECURITY AGREEMENT

This **TERMINATION OF TRADEMARK SECURITY AGREEMENT**, dated as of August 14, 2023 (this "*Termination*"), is executed by TC Lending, LLC ("*Collateral Agent*"), with an address at 2100 McKinney Avenue, Suite 1500, Dallas, TX 75201, in favor of Acroprint Tech Inc., a Delaware corporation ("*Grantor*"), with an address at 5640 Departure Drive, Raleigh, NC 27616.

### RECITALS

**WHEREAS**, Grantor, certain affiliates of Grantor and Collateral Agent entered into that certain Pledge and Security Agreement, dated as of October 19, 2020 (as amended or otherwise modified from time to time, the "*Security Agreement*");

**WHEREAS**, in connection with the Security Agreement, Grantor and Collateral Agent entered into that certain Grant of a Security Interest – Trademarks, dated as of October 19, 2020, recorded in the United States Patent and Trademark Office at Reel/Frame 7079/0396 (as amended or otherwise modified from time to time, the "*Agreement*") pursuant to which Grantor granted to Collateral Agent a security interest in the Collateral (as defined in the Agreement); and

**WHEREAS**, Collateral Agent has agreed to terminate and release its security interest in the Collateral (as defined in the Agreement) as herein provided.

**NOW, THEREFORE**, in consideration of the foregoing, Collateral Agent agrees as follows:


1. Collateral Agent, without representation, warranty or recourse, hereby terminates its security interest in the Collateral (as defined in the Agreement), including the Trademarks (as defined in the Agreement) and Trademark applications listed on *Schedule 1* hereto.
2. Collateral Agent hereby authorizes Grantor or Grantor's agent to record this Termination with the United States Patent and Trademark Office and any other relevant governmental authority, at the Grantor's sole cost and expense.
3. This Termination and the rights and obligations of the parties under this Termination shall be governed by, and construed and interpreted in accordance with, the law of the State of New York.
