## TRADEMARK ASSIGNMENT

This Trademark Assignment (the "Assignment"), dated August 16, 2023, is entered into by Zoetis Services LLC, a Delaware limited liability company, having a principal place of business at 10 Sylvan Way, Parsippany, New Jersey 07054 (the "Assignor"), for the benefit of Boehringer Ingelheim Animal Health USA Inc., a Delaware corporation, having a principal place of business at 3239 Satellite Blvd NW, Duluth, Georgia 30096 (the "Assignee").

WHEREAS, Assignor has the sole and entire right, title, and interest in and to the trademark IMMUNE-GUARD, U.S. Registration Number 1,756,402 for "preparation, incorporated into a veterinary vaccine, which inactivates viral components therein" in Class 5 (hereinafter referred to as the "Trademark"); and

WHEREAS, Assignee wishes to acquire from Assignor, and Assignor wishes to assign, transfer, convey, and deliver to Assignee, the Trademark, together with all common law rights therein and all goodwill of the business connected with the use of, and symbolized by, the Trademark.

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor agrees as follows:

1. Assignor hereby irrevocably conveys, transfers, and assigns to the Assignee the entire right, title and interest in and to the Trademark and the trademark which is the subject thereof, including all goodwill of the business connected with the use of, and symbolized by, said Trademark, whether based on common law or the laws of various states, and all past and present rights and powers, statutory and common law, which have accrued or may accrue to Assignor of any and all kind or nature appertaining to the Trademark, including, without limitation, the right (but not the obligation) to assert such registered trademark and other assigned rights to collect for license royalties and all past, present, and future infringements, and claims for damages and the proceeds thereof that have occurred or may occur.

2. Assignor hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office to record and register this Assignment upon request by Assignee. Following the date hereof, upon Assignee's reasonable request, Assignor shall take such steps and actions, and provide such cooperation and assistance to Assignee and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be necessary to effect, evidence, or perfect the assignment of the Trademark to Assignee, or any assignee or successor thereto.

3. A signed copy of this Assignment delivered by e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment.

4. This Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.

5. This Assignment and any claim, controversy, dispute, or cause of action (whether in contract, tort, or otherwise) based upon, arising out of, or relating to this Assignment and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Delaware, without giving effect to any choice or conflict of law provision or rule (whether of the State of Delaware or any other jurisdiction).
