**BETWEEN**

- (1) **Stacked Brands Limited** of 15 Queen Square, Leeds, United Kingdom, LS2 8AJ (UK Limited Company) (hereinafter “the Assignor”), and
- (2) **Roar Ambition Ltd** of Whitehall Waterfront Unit G4, 2 Riverside Way, Leeds, United Kingdom, LS1 4EH (UK Limited Company) (hereinafter called “the Assignee”)

**Recitals**

- A The Assignor is the owner of the Trade Mark, listed in the attached schedule in the (hereinafter called “the Trade Mark”).
- B The Assignor wishes to assign to the Assignee its entire right, interest and title in the Trade Mark and all goodwill attached thereto.

**Operative Clauses**

- 1 In consideration for the sum of £1 (one pound sterling) now paid by the Assignee to the Assignor (receipt of which is hereby acknowledged by the Assignor), the Assignor hereby assigns to the Assignee its entire rights, title and interest in and to the Trade Mark together with all goodwill in the business attached to the Trade Mark and the right to sue for past infringements and the right to retain any damages or other benefit as a result of such action.
- 2 The Assignor hereby covenants with the Assignee that the Assignor will at the expense of the Assignee execute, sign and do all such acts, documents, instruments, applications and things as may reasonably be required by the Assignee for the Assignee or the nominee of the Assignee to secure a full assignment of the Trade Mark hereby assigned.
- 3 This assignment shall be governed and construed in accordance with English law and the parties submit to the jurisdiction of the English courts.
