**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, the Grantor granted the Grantee, under the terms of the Trademark Security Agreement, a continuing security interest (the "Security Interest") in favor of the Grantee, in all of its right, title and interest in and to the Collateral, including without limitation the Trademarks listed in Schedule A.


WHEREAS, the Grantee has agreed to terminate and release its security interest in all such Collateral as herein provided.
