## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this “Release”) is made as of August 17, 2023 (the “Effective Date”) by BMO Harris Bank N.A. (the “Lender”), in favor of VALENCIA PIPE COMPANY, EPIC CHEMICALS, LLC and HOME-FLEX, LLC (“Grantor”). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Credit Agreement or the Trademark Security Agreement (as defined below), as applicable.

**WHEREAS**, Grantor and Lender entered into that certain Credit and Security Agreement, dated as of April 7, 2022 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the “Credit Agreement”), which required the parties to enter into the Trademark Security Agreement (defined below);

**WHEREAS**, Grantor and Lender entered into that certain Grant of a Security Interest in Trademarks, dated April 7, 2022 (the “Trademark Security Agreement”), under which Grantor mortgaged, pledged and hypothecated to the Lender, and granted to the Lender a Lien on and security interest in, all of its right, title and interest in, to and under its Trademarks and applications therefor listed on Schedule 1 hereto; and the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on April 11, 2022, at Reel 7687, Frame 0686;

**WHEREAS**, Grantor has satisfied the terms of the Trademark Security Agreement and requests a specific release of the security interest granted and recorded against the Trademark Collateral.


**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby, on behalf of itself and the Secured Parties, (i) terminates the Trademark Security Agreement, (ii) releases any and all liens, security interests, right, title and interest the Lender or any Secured Party may have in, to or under the Trademark Collateral (including the items listed on Schedule 1 hereto), (iii) re-assigns to Grantor, any right, title or interest the Lender or any Secured Party may have in, to or under the Trademark Collateral (including the items listed on Schedule 1 hereto) and (iv) hereby authorizes the Grantor or the Grantor’s authorized representative or designee to record this Release with the United States Patent and Trademark Office as evidence of such release and termination

This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of Illinois.


