Ladies and Gentlemen:

Please be advised that pursuant to the Pledge and Security Agreement dated as of April 11, 2023 (as supplemented by that certain Assumption Agreement dated as of August 17, 2023, between, among others, North Six, Inc., a New York corporation (the "Pledgor"), in favor of the Security Agent (as defined below) and as may be further amended, modified, extended, restated, renewed, replaced, or supplemented from time to time, the "Agreement"), between, among others, TOGETHER GROUP HOLDINGS PLC, a company incorporated in England and Wales with registration number 10963571, MATCAP VENTURES LLP, a limited liability partnership incorporated in England and Wales with registration number OC442463, TG STUDIOS US, LLC, a Delaware limited liability company, and ALTER DOMUS TRUSTEES (UK) LIMITED, in its capacity as security trustee (the "Security Agent") for the Secured Parties referenced therein, the undersigned Pledgor has granted a continuing security interest in and continuing lien upon the trademarks shown on Schedule 1 attached hereto, including all the goodwill associated therewith, to the Security Agent for the ratable benefit of the Secured Parties; provided that such continuing security interest shall not extend to any U.S. federal trademark application that was filed or is pending registration based on an intent-to-use basis under Section 1(b) of the Lanham Act, 15 U.S.C. § 1051, unless and until an acceptable Amendment to Allege Use or Statement of Use has been filed with and accepted by the United States Patent and Trademark Office, provided that such applications shall automatically be included in Collateral thereafter.

The undersigned Pledgor and the Security Agent, on behalf of the Secured Parties, hereby acknowledge and agree that the security interest in the foregoing trademarks (a) is subject to the terms and conditions of the Agreement and may only be terminated in accordance with the terms of said Agreement and (b) is not to be construed as an assignment of any trademark.


