**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (“Termination and Release”) is made as of August 11, 2023, by GLAS AMERICAS LLC, in its capacity as successor Collateral Agent (in such capacity, the “Collateral Agent”), in favor of DIEBOLD NIXDORF, INCORPORATED (the “Pledgor”).

**WITNESSETH:**

WHEREAS, pursuant to (i) the Security Agreement, dated as of July 20, 2020 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), among the Pledgor, the other parties from time to time party thereto and the Collateral Agent and (ii) that certain Trademark Security Agreement, dated as of July 20, 2020 (the “Trademark Security Agreement”), between the Pledgor and the Collateral Agent, the Pledgor pledged and granted to the Collateral Agent for the benefit of the Secured Parties a lien on and security interest (the “Security Interest”) in and to all of the Pledgor’s right, title and interest in, to and under (a) the Trademarks of the Pledgor listed on Schedule A attached hereto; (b) all Goodwill associated with such Trademarks; and (c) all Proceeds of any and all of the foregoing (other than Excluded Assets) (collectively, the “Trademark Collateral”);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 31, 2020 at Reel 7012, Frame 0419; and

WHEREAS, the Pledgor has requested and the Collateral Agent has agreed to release its Security Interest in the Trademark Collateral, including the Trademarks of the Pledgor listed on Schedule A attached hereto.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms defined in the Security Agreement or the Trademark Security Agreement, as applicable, and used herein have the meaning given to them in the Security Agreement or the Trademark Security Agreement, as applicable.

2. Release. The Collateral Agent, without recourse, representation or warranty of any kind, hereby releases, terminates, discharges, and cancels its Security Interest in and to the Trademark Collateral, including the Trademarks of the Pledgor listed on Schedule A attached hereto, arising under the Security Agreement or the Trademark Security Agreement, as applicable, and any right, title or interest of the Collateral Agent in the Trademark Collateral, including the Trademarks of the Pledgor listed on Schedule A attached hereto, arising under the Security Agreement or the Trademark Security Agreement, as applicable, shall hereby cease and become void. If and to the extent the Collateral Agent has acquired under the Security Agreement or the Trademark Security Agreement, as applicable, any right, title or interest in and to the Trademark Collateral, including the Trademarks of the Pledgor listed on Schedule A attached hereto, the Collateral Agent, without recourse, representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Pledgor.

3. Termination. The Collateral Agent, without recourse, representation or warranty of any kind, hereby terminates and cancels the Trademark Security Agreement.

4. Further Assurances. The Collateral Agent hereby agrees, upon the reasonable written request and at the sole expense of the Pledgor, to duly execute, acknowledge, procure and deliver any further documents and do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby. The Collateral Agent hereby authorizes and requests that the Commissioner for Trademarks of the United States Patent and Trademark Office record this Termination and Release.


