**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of August 16, 2023 (this “Release”), is made by CIBC BANK USA, as administrative agent (the “Administrative Agent”), in favor of ATC Transportation LLC, a Wisconsin limited liability company (“Grantor”).

WHEREAS, pursuant to that certain Guaranty and Collateral Agreement dated as of December 23, 2020 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “Security Agreement”), by and among the Grantor, Administrative Agent, and others party thereto, Grantor granted to the Administrative Agent, for the benefit of the Secured Parties, a continuing security interest in and continuing lien upon, among other things, Grantor’s right, title and interest in and to the trademarks set forth on Schedule A hereto (collectively, the “Trademark Collateral”); and

WHEREAS, pursuant to the Security Agreement, Grantor executed and delivered to Administrative Agent the Notice of Grant of Security Interest in Trademarks recorded at the United States Patent and Trademark Office (“USPTO”) on December 28, 2020 at Reel 7198 Frame 0561 (“Notice”).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, on behalf of the Secured Parties, and Grantor agree as follows:

1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Notice.
2. Termination and Release. Administrative Agent, on behalf of the Secured Parties, without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:
 - (a) terminates, cancels, discharges, and releases the continuing security interest in and continuing lien upon Grantor’s right, title and interest in and to the Trademark Collateral; and
 - (b) authorizes the recordation of this Release with the USPTO at Grantor’s expense.
3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of Illinois.
