### **TRADEMARK ASSIGNMENT AGREEMENT**

#### **1. ASSIGNED TRADEMARKS**

The term “Assigned Trademarks” means the trademarks, service marks, service names, trade dress, trade names, logos, symbols, corporate names and other source or business identifiers set forth on Schedule 1 attached hereto, and all registrations, applications, renewals or extensions of the foregoing.

#### **2. ASSIGNMENT**

Assignors hereby sell, assign, convey and transfer, and agree to assign, convey and transfer, to Assignee, and Assignee hereby accepts, all of Assignors’ rights, title and interests in, to and under the Assigned Trademarks, together with all goodwill associated with the Assigned Trademarks and the goodwill of the business connected to and symbolized by the Assigned Trademarks, for Assignee’s own use and enjoyment, and for the use and enjoyment of Assignee’s successors and assigns, as fully and entirely as the same would have been held and enjoyed by Assignors if this Trademark Assignment had not been made, together with all income, royalties or payments due or payable as of the date hereof or thereafter with respect to the Assigned Trademarks, and all claims for damages by reason of past, present or future infringement or other unauthorized use of the Assigned Trademarks, with the right to sue for, enforce and collect the same for Assignee’s own use and enjoyment and for the use and enjoyment of its successors or assigns, and any other rights, privileges, claims and causes of action in respect of the Assigned Trademarks, free and clear of any liens or indebtedness.

#### **3. FURTHER ACTIONS**

Following the date of this Trademark Assignment, upon Assignee’s reasonable request, Assignors shall take such steps and actions, and provide such cooperation and assistance to

Assignee and its successors, assigns and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be reasonably necessary to effect, evidence, enforce or perfect the assignment of the Assigned Trademarks to Assignee, or any assignee or successor thereto.


#### **4. RECORDATION**
