**CONFIRMATORY ASSIGNMENT**

AND, Assignor and IPM hereby covenant and agree to take such further actions and execute such further documents as may be reasonably necessary or appropriate to carry out this Assignment, including, for the avoidance of doubt, the execution and recordation of additional or amended confirmatory assignments to record the transfer of the Trademarks at all applicable registries in IPM’s name.
