RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is made as of August 18, 2023 (the "Effective Date") by **FEAC AGENT, LLC** as administrative agent and collateral agent for the Lenders (in such capacities, together with its successors and assigns in such capacities, the "Agent") in favor of **QUALITYMETRIC INCORPORATED, LLC** (formerly known as **QUARTERMASTER NEWCO, LLC**), a Delaware limited liability company (the "Grantor").

WHEREAS, Grantor and certain other affiliates of Grantors executed and delivered that certain Security Agreement, dated as of July 31, 2020 (the "Security Agreement"), in favor of the Agent. Capitalized terms used but not defined herein shall have the meanings ascribed thereto in the Security Agreement.

WHEREAS, pursuant to the terms of the Security Agreement, Grantor duly authorized the execution, delivery and performance of that certain Trademark Security Agreement, effective as of July 31, 2020, in favor of the Agent (the "Trademark Security Agreement").

WHEREAS, pursuant to the Trademark Security Agreement, Grantor pledged and granted to the Agent, for the benefit of the Secured Parties, a security interest in all of Grantor's right, title and interest in, to and under all of the Trademark Collateral (as defined therein), including, without limitation, the trademarks and trademark applications set forth on Schedule A attached hereto.

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 31, 2020 at Reel 7012, Frame 0630.

WHEREAS, Grantor has paid or caused to be paid all of the Secured Obligations and has terminated the Commitments.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. The Agent hereby terminates the Trademark Security Agreement and the Security Agreement, and hereby terminates, cancels, releases, and discharges any and all liens and security interests it has in, to and under the Trademark Collateral, including the trademarks and trademark applications set forth on Schedule A attached hereto and hereby reassigns any and all right, title and interest in and to any and all Trademark Collateral to the Grantor.

2. The Agent authorizes and requests that the United States Commissioner of Patents and Trademarks and any other applicable officer in any successor office or any similar office in any other country record this Release.
