(i) the goodwill of the business relating to the Products in respect upon which the Mark(s) are used and for which they are registered;

(ii) all income, royalties, and damages hereafter due or payable to Assignor with respect to the Mark(s), including, without limitation, damages and payments for past or future infringements and misappropriations of the Mark(s); and

(iii) all rights to sue for past, present and future infringement or misappropriation of the Mark(s); and


(iv) the product(s), label(s), formula(s), and promotional material(s) upon which the Trademark is used, together with other assets relating to the Mark(s).


