DECLARATION

I, Dyan M. House, hereby declare the following:

1) This request for correction by declaration pertains to the following U.S. registrations: (a) 5159190; and (b) 4756547.

2) On November 28, 2017, a change of name document was filed for the above-referenced registrations to update the owner name from HAVELOCK NORTH FRUIT CO. LIMITED to HN HOLDCO LIMITED. This change of name was recorded at Reel/Frame 6214/0562. The document in support of this name change was uploaded to the Trademark Database as "Assignment 2 of 2."


