Pursuant to Section 252 of the General Corporation Law of the State of Delaware

Integrated Practice Solutions, Inc., a Delaware corporation (the "Corporation"), does hereby certify to the following information relating to the merger (the "Merger") of Ingenium Business Solutions, Inc., a Florida corporation (the "Disappearing Entity"), with and into the Corporation.

FIRST: The names and states of incorporation of each constituent corporation to the Merger (the "Constituent Corporations") are as follows:
