ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
LAYERED AND LONG INC.

Pursuant to RCW 23B.10.060, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Layered and Long Inc. (the "*Corporation*").

SECOND: The amendment to the Articles of Incorporation as adopted is as follows:
