DOMESTIC CORPORATIONS**

Pursuant to Title 8, Section 251(c) of the Delaware General Corporation Law (the “DGCL”), CCC Intelligent Solutions Inc., a corporation organized and existing under the laws of the State of Delaware (the “Company”), does hereby certify that:

FIRST: The names and states of incorporation of the constituent corporations are the following: (i) the name of the surviving corporation is CCC Intelligent Solutions Inc., a Delaware corporation, and (ii) the name of the corporation being merged into this surviving corporation is Safekeep, Inc., a Delaware corporation (“Safekeep” and together with the Company, the “Constituent Corporations”).

SECOND: An Agreement and Plan of Merger, dated December 29, 2022 (the “Merger Agreement”) was entered into by and between the Company and Safekeep. The Merger Agreement has been approved, adopted, executed and acknowledged by each of the Constituent Corporations in accordance with the requirements of Section 251(c) of the DGCL.

THIRD: The name of the surviving corporation is CCC Intelligent Solutions Inc.

FOURTH: The Second Amended and Restated Certificate of Incorporation of the Company, as in effect immediately prior to the Effective Time (as defined below), shall be the certificate of incorporation of the surviving corporation.

FIFTH: The merger is to become effective upon the filing of this Certificate of Merger (the “Effective Time”).


SIXTH: The executed Merger Agreement is on file at 167 N. Green Street, 9th Floor, Chicago, IL 60607, the place of business of the surviving corporation.

SEVENTH: A copy of the Merger Agreement will be furnished by the surviving corporation, on request and without cost, to any stockholder of any of the Constituent Corporations.
