**RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST**

This **RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST** (this "Release"), effective as of August 25, 2023 is made by **MIDCAP FINANCIAL TRUST** (in its individual capacity, "MidCap"), as the Administrative Agent (as defined in the Credit Agreement referred to below), in favor of **RHODES FINANCIAL SERVICES, LLC**, a Delaware limited liability company (the "Grantor"), and any successor or assign of the Grantor with respect to the IP Collateral (as defined in the Intellectual Property Security Agreement referred to below).

**WHEREAS**, pursuant to that certain (i) Credit Agreement, dated as of December 31, 2020 (as amended, restated, amended and restated, replaced, supplemented or otherwise modified from time to time, the "Credit Agreement"), by and among MEP-TS INTERMEDIATE, LLC, a Delaware limited liability company ("Holdings"), MEP-TS MIDCO LLC, a Delaware limited liability (the "Borrower"), the subsidiaries of the Borrower party thereto as subsidiary guarantors, the several institutions or entities from time to time party thereto as lenders and MidCap, as the RCF Agent (as defined therein) and as the Administrative Agent, (ii) Guarantee and Collateral Agreement, dated as of December 31, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified or replaced from time to time, the "Guarantee and Collateral Agreement"), by and among Holdings, the Borrower, the other grantors from time to time party thereto and the Administrative Agent and (iii) Intellectual Property Security Agreement, dated as of December 31, 2020 (the "Intellectual Property Security Agreement"), by and between the Grantor and the Administrative Agent, the Grantor granted to the Administrative Agent a continuing security interest in all of the Grantor's right, title and interest in, to and under all IP Collateral.

**WHEREAS**, the Intellectual Property Security Agreement was recorded in the United States Patent and Trademark Office (the "USPTO") on December 31, 2020 at Reel 7152 and Frame 0188.

**WHEREAS**, the Intellectual Property Security Agreement was recorded in the United States Copyright Office (the "USCO") on December 31, 2020.

**WHEREAS**, the Administrative Agent has agreed to terminate and release its security interest in the IP Collateral.

**NOW, THEREFORE**, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Administrative Agent hereby (i) irrevocably terminates the Intellectual Property Security Agreement, (ii) unconditionally and irrevocably discharges, terminates, cancels and releases all liens and security interests in the IP Collateral, including all Trademark Collateral (as defined in the Intellectual Property Security Agreement), including the trademarks listed in Schedule A hereto, and all Copyright Collateral (as defined in the Intellectual Property Security Agreement), including the copyrights listed in Schedule B hereto, and (iii) re-assigns to the Grantor any right, title or interest that the Administrative Agent may have in the IP Collateral.

The Grantor, and any successor to the Grantor (including any person or entity hereafter holding any right, title or interest in or to the IP Collateral), are hereby authorized to record this Release in the USCO and the USPTO, as applicable.

This Release may be executed in any number of counterparts (including by telecopy or other electronic transmission), each of which when so executed shall be deemed an original and all of which taken together shall constitute one and the same agreement.

THIS RELEASE AND ANY CLAIM, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS RELEASE AND THE TRANSACTIONS CONTEMPLATED HEREBY SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.

The Administrative Agent shall, at the expense of the Grantor, promptly execute and deliver to Grantor all documents and take such other actions (including, without limitation, making of all filings) as Grantor shall reasonably request in writing to evidence the termination and release of the security interest in the IP Collateral.

**IN WITNESS WHEREOF**, the Administrative Agent has caused this Release to be duly executed and delivered by its duly authorized officer as of the date first set forth above.
