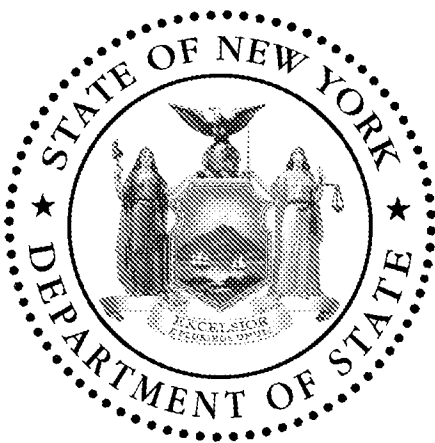

6. The date when the Certificate of Incorporation of Soft-tex International, Inc., a New York corporation, formerly known as Perry Textiles, Inc., was filed by the Department of State of the State of New York was the 12th day of November, 1986.

7. The Surviving Corporation agrees that it may be served with process in the State of New York in any action or special proceeding for the enforcement of any liability or obligation of any constituent corporation previously amendable to suit in the State of New York, and for the enforcement under the New York Business Corporation Law, of the right of shareholders of any constituent domestic corporation to receive payment for their shares against the Surviving Corporation.

(a) The constituent domestic corporation hereby certifies that all fees and taxes, including penalties and interest, administered by the Department of Taxation and Finance of the State of New York which are now due and payable by the constituent domestic corporation have been paid and that a cessation franchise tax report, estimated or final, through the anticipated date of the merger has been filed by the constituent domestic corporation.
