**INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT**

THIS INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (this “Agreement”), dated as of July 18, 2023 (the “Effective Date”), is made by and among Dream 545 Weston Canal Road, LLC, a New Jersey limited liability company (“Buyer”), BBY Acquisition Co. LLC, a Delaware limited liability company (“Assignee”), Bed Bath & Beyond Inc., a New York corporation (“BBBY”), and certain Subsidiaries of BBY set forth on Annex A hereto (collectively and together with BBY, “Assignors” and each individually an “Assignor”). Capitalized terms used herein and not otherwise defined herein have the meaning set forth in the Purchase Agreement (as defined below).

WHEREAS, pursuant to that certain Asset Purchase Agreement (the “Purchase Agreement”), dated as of June 30, 2023, by and among Buyer, Mark Srour-Serure, Dream on Me Industries, Inc., a New York corporation, BBY and certain of its Subsidiaries, the Assignors have agreed to sell and assign to Buyer, and Buyer has agreed to purchase, acquire and accept, all of the Assignors’ right, title and interest in, to or under certain Acquired Assets, including all Business IP; and

WHEREAS, this Agreement is being executed and delivered in accordance with the terms of the Purchase Agreement to perfect and provide notice of the assignments and transfers of Business IP required under the Purchase Agreement.

NOW, THEREFORE, in consideration of the mutual promises and covenants set forth below, the receipt and sufficiency of which are hereby acknowledged:

1. Designation. Buyer hereby designates to Assignee, pursuant to Section 12.4 of the Purchase Agreement, all of Buyer’s rights to acquire the Acquired Assets in accordance with the Purchase Agreement, and hereby directs Assignors to deliver the Acquired Assets to Assignee in accordance with the Purchase Agreement, and Assignee hereby agrees to so acquire the Acquired Assets.

2. Assignment. Each Assignor hereby irrevocably, absolutely, and unconditionally assigns, transfers and conveys to Assignee, all of its right, title and interest in and to all of the Business IP, including:

(i) the copyright registrations and applications, and exclusive copyright licenses, identified on Schedule I;

(ii) the Trademarks identified on Schedule II, all registrations, extensions, and renewals thereof, together with any and all goodwill associated therewith;

(iii) the Internet Properties identified on Schedule III;

(iv) all rights of any kind whatsoever of each Assignor accruing under any Business IP (including any of the foregoing) provided under the applicable Laws of any jurisdiction, by international treaties and conventions, and otherwise throughout the world;

(v) all rights to collect royalties and other proceeds and payments in connection with any Business IP (including any of the foregoing); and

(vi) all rights to sue and recover for any past, present or future infringement, dilution, misappropriation or other violation of any Business IP (including any of the foregoing).

3. Domain Name Transfers. Each Assignor shall promptly carry out the domain name transfer procedures and execute any additional transfer documents required by any applicable registrars of the domain names assigned hereunder, and shall promptly provide any authorization codes known or accessible to Assignors that are necessary to effect such transfers. Each Assignor further hereby authorizes and requests all applicable domain registrars to transfer the domain names assigned hereunder to Assignee or such persons or entities designated by Assignee.

4. IP Recordation & Transfer. Each Assignor hereby authorizes and requests that Assignee file and record with the United States Patent & Trademark Office, the United States Copyright Office, and any and all other applicable registrars in other jurisdictions throughout the world, and that any other steps necessary steps be taken to effect, evidence and perfect the assignments, transfers and conveyances described under this Agreement.

5. Successors and Assigns. The provision of this Agreement shall bind and inure to the benefit of Assignors and Assignee and their respective successors and permitted assigns.

6. Purchase Agreement. This Agreement is made subject to the terms of the Purchase Agreement, and nothing in this Agreement shall alter any liability or obligation of the Parties arising under the Purchase Agreement. Article I (*Definitions*) of the Purchase Agreement, including the terms of interpretation and construction thereunder, and Sections 12.4 through 12.9 and 12.11 through 12.16 of the Purchase Agreement are incorporated herein *mutatis mutandis*.
