TRADEMARK ASSIGNMENT AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby distributes, sells, transfers, assigns and otherwise conveys unto Assignee, its successors and assigns, all of its right, title and interest in and to the Trademark, including priority filing rights, together with the goodwill connected with the use of and symbolized by the Trademark and all U.S. applications and registrations related thereto, and all rights to proceeds of the foregoing, including without limitation any rights of action by Assignor, and the right to take proceedings and to seek and recover damages and all other available remedies against third parties for past, present or future infringement of the Trademark. Assignor also transfers and assigns to Assignee the ongoing and existing businesses associated with the Trademark and the goods and services related thereto.
