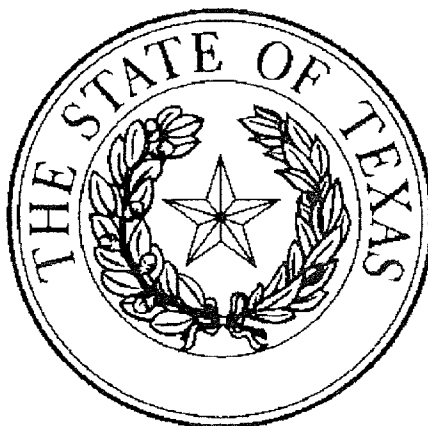

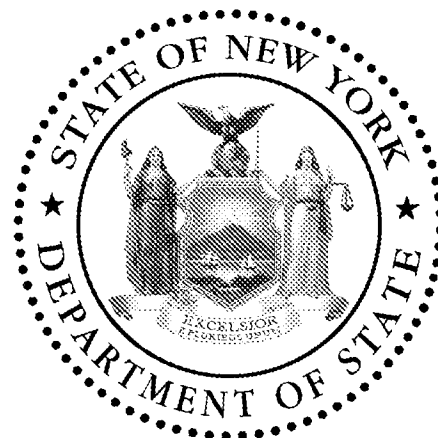

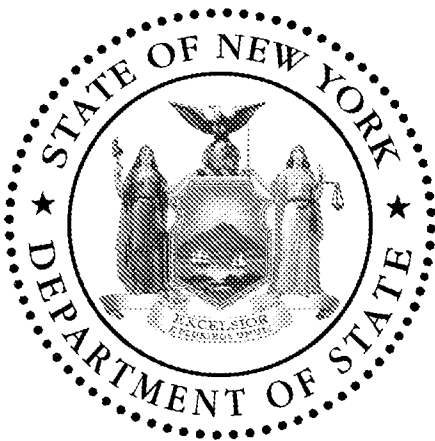

FIRST: The name of each constituent entity that is to merge is:

- a) The name of the Non-Surviving Business Entity is Profiles International, LLC, a Texas Limited Liability Company (the "**Merged LLC**")
- b) The name of the surviving corporation is John Wiley & Sons, Inc., a New York corporation (the "**Surviving Corporation**"). The name under which John Wiley & Sons, Inc. was originally formed is JOHN WILEY AND SONS.

SECOND: The certificate of incorporation or articles of organization of each constituent domestic entity was filed for John Wiley & Sons, Inc. by the Department of State of New York on January 15, 1904.

THIRD: The initial certificate of formation of Profiles International, LLC was filed by the Department of State of Texas on April 30, 2014. The Merged LLC is not qualified in the State of New York. The Surviving Corporation is qualified in the State of Texas and its application for authority was filed by the department of state of Texas on October 28, 1960.

FOURTH: The name of the Surviving Corporation is and shall continue to be John Wiley & Sons, Inc.

FIFTH: The agreement of merger has been approved and executed by each of the domestic limited liability companies or domestic other business entities that is a party thereto; and the merger is permitted by the jurisdiction of incorporation or organization of each foreign constituent entity and is in compliance therewith.

SIXTH: The effective date of the merger, if it is not to be effective upon the filing of the certificate of merger, is August 1, 2023.

SEVENTH: The Merged LLC has complied with the provisions of the laws of its jurisdiction of incorporation applicable to this merger and this merger is permitted by such laws. This merger was authorized and approved by the sole member of the Merged LLC.
