FIRST: That the Corporation’s Restated Certificate of Incorporation is hereby amended as set forth below:

1. Article 1 of the Corporation’s Restated Certificate of Incorporation is hereby amended in its entirety and replaced with the following:


“The name of this corporation is SS&C GIDS, Inc. (the “**Corporation**”).”
