**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of June 21, 2023, by **SIXTH STREET SPECIALTY LENDING EUROPE I ADVISORS, LTD.** (formerly **TPG SPECIALTY LENDING EUROPE I ADVISORS, LTD.**), as Administrative Agent for the Lenders (in such capacity, together with its successors and assigns, “Agent”) (pursuant to (i) that certain U.S. Guarantee and Collateral Agreement, dated as of April 26, 2016 (as amended, amended and restated, supplemented, restructured or otherwise modified, renewed or replaced from time to time prior to the date hereof), between, among others, the Agent, each Grantor, and certain of the Grantors’ affiliates and (ii) that certain Credit Agreement, dated as of April 26, 2016 (as amended, amended and restated, supplemented, restructured or otherwise modified, renewed or replaced from time to time prior to the date hereof), between, among others, each Grantor, certain of the Grantors’ affiliates, the Agent, and certain Lenders party thereto), in favor of **SINTECMEDIA, NYC, INC.**, formerly known as **OPERATIVE MEDIA, INC.**, a Delaware corporation and **SOLBRIGHT, INC.**, a Delaware corporation (each a “Grantor”).

W I T N E S S E T H:

WHEREAS, each Grantor entered into that certain Trademark Security Agreement dated as of December 23, 2016 (the “Trademark Security Agreement”) with Agent, notice of which was submitted to the United States Patent and Trademark Office for recording and was recorded on December 5, 2020 at Reel 007124, Frame 0207.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, each Grantor granted the Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Agent, in all of its right, title and interest in and to the Trademarks, including without limitation the Trademarks listed in **Schedule A**.

WHEREAS, the Agent has agreed to terminate and release the Security Interest in all such Trademarks as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates, cancels and discharges any and all of its interest in the Trademarks of each Grantor, and assigns, transfers and conveys to each Grantor any interest in such intellectual property, including the Security Interest, and authorizes the recordation of this Release with the United States Patent and Trademark Office at each Grantor’s expense, to the extent applicable.


